DEFAULT JUDGMENT

THE DEFENDANT MARY WYLY also known as MARY CROFT, not having delivered any Statement of Defence or a Demand of Notice, it is this day adjudged that:

1. The Plaintiff does recover Judgment against the Defendant in the amount of \$5,349.71 for the first Visa, together with interest thereon at a per diem rate of \$2.71 per day, from January 17th, 2006, to May 3rd, 2007, in the further amount of 471 days x \$2.71 = \$1,276.41, for a total judgment on the first Visa of \$6,626.12.
2. The Plaintiff does recover Judgment against the Defendant in the amount of \$5,647.34 for the second Visa, together with interest thereon at a per diem rate of \$2.86 per day from January 17th, 2006 to May 3rd, 2007, in the further amount of 471 days x \$2.86 per day = \$1,347.06, for a total judgment on the second Visa of \$6,994.40.
3. The total Judgment herein is for the combined sum of \$13,620.52 plus costs to be taxed.

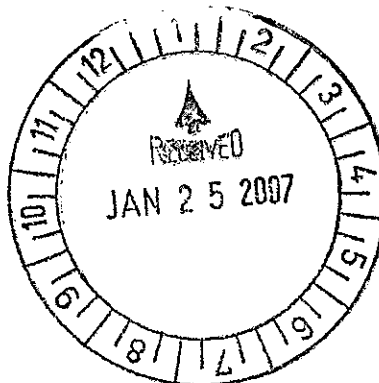
